

SUCCESS RATE

94 percent of surveyed Project EXCEL students over the past three years have found full-time or part-time employment, are pursuing graduate education, volunteering full-time, or have entered into military service within six months of graduation.

REQUIREMENTS TO APPLY

- Diagnosis of a learning difference, such as a learning disability and/or Attention Deficit Hyperactivity Disorder.
- Acceptance into the University.

EXTRA SERVICES

In addition to the federally mandated services such as accommodated testing, note-takers, texts in alternate formats, etc. (provided at no charge), Project EXCEL offers:

- Adult professional tutoring.
- Academic progress monitoring.
- Academic advising with attention to each student's specific learning needs.
- Organization and time-management skills development and coaching.
- Direct instruction in academic success strategies, reading in content areas, and development of coping skills.
- Executive function support (impulse control, emotional control, flexible thinking, working memory, self-monitoring, planning and prioritizing, task initiation, and organization).
- Optional freshmen mentoring.
- Development of self-advocacy skills.

As a Project EXCEL student, you are a partner in your education as you discover your strengths, address learning challenges, and acquire skills. Along with a willingness to recognize disability so you can focus on ability, you'll be expected to demonstrate a desire for academic support and to advocate for services and assistance. As you actively pursue your college degree, you'll develop effective strategies for studying, time management, and decision making.

EXCEL PROGRAM

The EXCEL Program is designed to provide comprehensive academic support for undergraduate students as they move from the secondary setting to post-secondary studies. Offerings include:

- Individual study schedules.
- Weekly professional tutoring.
- Weekly coaching sessions for freshmen to enhance time management and organizational skills; thereafter, sessions are based on GPA criteria or by request.
- Monitoring of student progress and academic counseling (as needed).
- Instruction in learning strategies, reading in the content areas, and developing coping skills.
- Consultative advising with attention to each student's specific learning needs.
- Executive function support (impulse control, emotional control, flexible thinking, working memory, self-monitoring, planning and prioritizing, task initiation, and organization).
- Mentoring offered for freshmen students.

Project EXCEL prides itself on being a "custom fit" academic support program, not a "one-size-fits-all" and is a fee-based service. Visit www.msj.edu/excel for the latest information.

ADDITIONAL SUPPORT

The Career & Experiential Education Center (CEEC) provides students with high impact practices including: co-op, service learning, and student philanthropy. Additionally, the CEEC assists students in achieving their professional goals through career development events, courses, and career coaching, as well as assistance with resume and interview preparation.

The Wellness Center provides Counseling and Health Services to all registered and enrolled students at no extra cost to students. The Wellness Center is staffed by licensed mental health providers and a Registered Nurse. A Medical Assistant and two doctors are available by appointment throughout the academic year. A student can visit the Wellness Center to schedule appointments or call 513-244-4949 for counseling services and 513-244-4769 for health services.

The University provides Read Write software to enrolled students. Read Write is a literacy support software that has been designed to address difficulties with writing, spelling, grammar, vocabulary, and reading.



DOCUMENTATION

The documentation includes a psychoeducational evaluation administered within three years of application, current Multi-Factored Evaluation (MFE) or Evaluation Team Report (ETR). The documentation must present reasonable evidence that college academic requirements can be successfully met.

Official disability documentation must be sent directly to Project EXCEL from the original source. In order to be considered, the assessment must be recent, relevant and be conducted by a certified and/or licensed professional. If available, the following components are helpful in designing a plan for individual students:

1. Aptitude testing (must include scaled scores)
2. Achievement testing (must include standard scores)
3. Disclosure of all concomitant conditions, including a diagnostic summary stating the Diagnostics and Statistics Manual diagnosis, discussion of functional implications, and recommendations for the post-secondary setting.

The Project EXCEL staff realizes that not all evaluations contain this information.

PROJECT EXCEL APPLICATION PROCESS

Students must be admitted to Mount St. Joseph University before applying to Project EXCEL.

Students interested in Project EXCEL are encouraged to apply as early as possible. Space is limited, and each application is evaluated carefully to identify students whose needs best match the scope of support offered in Project EXCEL. Applying to Project EXCEL requires the steps listed below. The forms, along with an application checklist, can be found at www.msj.edu/excel.

THE FORMS

1. Completion of the following forms:
 - Project EXCEL General Information Form
 - Project EXCEL Applicant Information Form
 - Project EXCEL School Record Form (traditional students only).
2. Submission of the following data:
 - documentation (psychoeducational administered within three years of application).
 - letter of recommendation from a non-family member who knows the student well.
3. On campus interview with the director of Project EXCEL.

DISABILITY SERVICES

In compliance with Section 504 of the rehabilitation Act of 1973, Mount St. Joseph University provides academic adjustments and auxiliary aids for students with physical or mental impairments that substantially limit or restrict one or more of such major life activities as walking, seeing, hearing, or learning.

The Mount provides, at no charge, these reasonable academic adjustments and auxiliary aids to meet the individual needs of eligible students. Advocacy assistance on disability related issues is also provided. Eligibility depends on the nature of the impairment and its impact on the particular individual and is based on documentation from a qualified professional.
